Decision Concerning Part One of the Second Instalment of Individual Claims

for Damages above US\$100,000 (Category "D" Claims) taken by the Governing

Council of the United Nations Compensation Commission at its 81st meeting,

held on 30 September 1998 at Geneva

The Governing Council,

<u>Having received</u>, in accordance with article 38 of the Provisional Rules for Claims Procedure, the third report of the Panel of Commissioners appointed to review individual claims for damages above US\$100,000 (category "D" claims), covering 250 individual claims, $\underline{1}$ /

- 1. <u>Approves</u> the recommendations made by the Panel of Commissioners, and, accordingly,
- 2. <u>Decides</u>, pursuant to article 40 of the Rules, to approve the amount of the recommended awards concerning 219 claims included in the report. The aggregate amounts per country or international organization, as listed in the annex of the report, are as follows:

- 3. <u>Reaffirms</u> that when funds become available payments shall be made in accordance with Decision 17 [S/AC.26/Dec.17 (1994)],
- 4. Recalls that when payments are made in accordance with Decision 17 [S/AC.26/Dec.17 (1994)] and pursuant to the terms of Decision 18 [S/AC.26/Dec.18 (1994)], Governments and international organizations shall distribute amounts received in respect of the approved awards within six months of receiving payment, and shall, not later than three months after the expiration of this time limit, provide information on such distribution,
- 5. Notes that no recommendations have been made at this stage for one claim referred to in paragraph six of the report,
- 6. <u>Requests</u> the Executive Secretary to provide a copy of the report to the Secretary-General and the Government of the Republic of Iraq and copies of the report and the tables containing the breakdown of the amounts to be paid to each individual claimant to each respective Government and international organization.
